**STATUTORY DECLARATION OF A PERSON NOMINATED AS A
CANDIDATE FOR PARLIAMENT**

PUBLIC ELECTIONS REGULATIONS, 2020 (C.I. 127) (Regulation 8)

I,do solemnly and
sincerely declare that:

- 1. I am a citizen of Ghana by birth.
- 2. I have attained the age of twenty-one years and above.
- 3. I am a registered voter.
- 4. I do not owe allegiance to any country other than Ghana.
- 5. (i) I am resident inConstituency
for which I can stand as a Candidate for election to Parliament; or
(ii) I have resided inConstituency for
a total period of not less than five years out of the ten years immediately preceding the
election for which I am standing; or

- (iii) I hail fromConstituency.
6. (i) I have paid all my taxes; or
- (ii) I have made arrangement satisfactory to the appropriate authority for the payment of my taxes.
7. I have not been adjudged or otherwise declared -
- (i) bankrupt under any law in force in Ghana from which I have not been discharged; or
- (ii) to be of unsound mind or detained as a criminal, or lunatic under any law in force in Ghana.
8. I have not been convicted -
- (i) for treason or for an offence involving the security of the state, fraud, dishonesty or moral turpitude; or
- (ii) for any other offence punishable by death or sentence of ten years or more; or
- (iii) for an offence relating to or connected with election under any law in force in Ghana at any time.
9. (a) I have not been found by the report of a Commission or a Committee of Inquiry to be incompetent to hold public office. I am not a person in respect of whom a Commission or a Committee of Inquiry has found that while being public officer, I acquired assets unlawfully, or defrauded the state, or misused or abused my office, or willfully acted in a manner prejudicial to the interest of the state.
- (b) I have not been convicted for an offence relating to, or connected with elections under a law in force in Ghana at any time.
10. I am not under sentence of death, or other sentence of imprisonment imposed on me by any court.
11. I have been disqualified to stand for election by a report of a Commission or Committee of Inquiry but
- i) ten years or more have passed since the end of the sentence, or the date of the publication of the report of the Commission or Committee of Inquiry;

or

ii) I have been pardoned.

12. I have been convicted for an offence but ten years or more have passed since the conviction, or I have been pardoned.

13. I am not disqualified to be registered as a voter under the provisions of any law relating to public elections.

14. I am not prohibited from standing election by any law in force in Ghana by reason of holding or acting in any office the functions of which involve a responsibility for, or in connection with, the conduct of an election or a responsibility for the compilation or revision of any electoral register.

15. I am not a member of the Police Service, the Prisons Service, the Armed Forces, the Judicial Service, the Legal Service, the Civil Service, the Audit Service, the Parliamentary Service, the Statistical Service, the National Fire Service, the Ghana Revenue Authority or the Immigration Service.

16. I am not a chief.

17. I am not otherwise disqualified from standing for election by any law in force in Ghana.

18. I have declared my assets in accordance with Public Office Holders (Declaration of Assets and Disqualification Act, 1998 (Act 550).

19. The information I have provided in the attached Candidate's Personal Record Form is true and accurate.
