9. I have not been found by the report of a commission or a committee of inquiry to be incompetent to hold public office. I am not a person in respect of whom a commission or a committee of inquiry has found that while being a public officer I acquired assets unlawfully or defrauded the state or misused or abused my office or willfully acted in a manner prejudicial to the interest of the state and the findings have not been set aside on appeal or judicial review.
10. Being a professional person, I have not been disqualified from practicing my profession on grounds of malpractice, fraud or dishonesty by the competent professional body.
11. I am not under sentence of death, or other sentence of imprisonment imposed on me by any court.
12. I am not disqualified to be registered as a voter under the provision of any law relating to public elections.
13. I am not disqualified for election by any law in force in Ghana by reason of my holding or acting in any office the functions of which involve a responsibility for or in connection with the conduct of an election or any responsibility for the compilation or revision of any electoral register.
14. I am not otherwise disqualified from standing for election by any law in force in Ghana. I make this solemn declaration knowing and believing the same to be true.
