- (i) for treason or for any offence involving the security of the State, fraud, dishonesty or moral-turpitude;
  - (ii) for any other offence punishable by death or a sentence of ten years or more;
  - (iii) for an offence relating to or connected with election under a law in force in Ghana at any time.
8. I have not been found by the report of a Commission or a Committee of Inquiry to be incompetent to hold public office. I am not a person in respect of whom a Commission or a Committee of Inquiry has found that while being a public officer, I acquired assets unlawfully or defrauded the State or misused or abused my office or willfully acted in a manner prejudicial to the interest of the State and the findings have not been set aside on appeal or Judicial Review.
9. I am not under a sentence of death, or other sentence of imprisonment imposed on me by any court.
10. I am not disqualified to be registered as a voter under the provisions of any law relating to public elections.
11. I am not disqualified for election by any law in force in Ghana by reason of my holding or acting in any office the functions of which involve a responsibility for or in connection with the conduct of an election or any responsibility involving the compilation or revision of any electoral register.
12. I am not otherwise disqualified from standing for election by any law in force in Ghana
